CST Studio, LLC. and its affiliated entities (“us,” “we” or “our”) created this Website Privacy Policy (“Privacy Policy”) to ensure the confidence of our visitors and clients (“you” or “your”) with our website (the “Site”), and to demonstrate our commitment to fair information practices and to protect your privacy.

Types of Information Collected

1. **Traffic Data Collected.** We automatically track and collect the following information when you visit our Site, including your: (i) IP address; (ii) domain server; (iii) type of computer; and (iv) type of web browser (collectively “Traffic Data”). Traffic Data is anonymous information that does not personally identify you but is helpful to improve your experience on the Site and to track site usage. We may also use “cookies” to customize content specific to your interests, to ensure that you do not see the same promotional content repeatedly and to store your password (if one is required to be issued) so you do not have to re-enter it each time you visit the Site.

2. **Personal Information Collected.** In order for you to access certain specialized services and/or to purchase products offered at the Site, we may require you to provide us with information that personally identifies you (“Personal Information”). Personal Information may include: (i) Contact Data (such as your name, mailing and e-mail addresses); (ii) and Demographic Data (such as your zip code, age and income). If you communicate with us by email, or complete survey forms online, any information you provide may be collected as Personal Information.

3. **Job Search.** Through our Site we provide access to an employment database under the title “Careers.” When you submit a resume through Careers, we will treat your resume with the same degree of confidentiality as if you had submitted it to us via regular mail. If you have any questions about this process, please contact us.

Confidentiality and Security of Personal Information

Except as otherwise provided in this Privacy Policy we will keep your personal information private and will not share it with third parties, unless such disclosure is necessary to: (a) comply with a court order or other legal process; or (b) protect our rights or property. Your personal information is stored on secure servers that are not accessible by third parties. We provide you with the capability to transmit your personal information via secured and encrypted channels if you use a similarly equipped web browser. We will obtain your permission to release your personal information before allowing you to use any of our services that require us to release your personal information to a third party.

Other Limits to Your Privacy

The Site contains links to other websites. We are not responsible for the privacy practices or the content of such websites. Please understand that any information that is disclosed in these areas becomes subject to the privacy policies and practices of those site. We have no control over its use and you should exercise caution when deciding to disclose your personal information.
